

BOMET COUNTY AT A GLANCE

THE NEED

Health and nutrition indicators in Bomet County reveal a need for investment and improvement (Bomet CIDP 2018-2022), which the county government is committed to providing. Only 37% of pregnant women make the recommended four antenatal care visits, well below the national average of 58%. Despite 94% of the women having received antenatal care from a health worker only 52% of the births were assisted by a skilled provider (KNBS, KDHS 2014). In Bomet County 36% (KNBS, KDHS 2014) of children aged six to 59 months are too short for their age — this means they have chronic malnutrition which is likely to negatively affect their survival, school performance and productivity in adulthood. Improving maternal health care is the primary focus of the Bomet County Integrated Development Plan 2018-2022. Nutrition International is supporting the county to implement multi-faceted programs focused on improving nutrition and health services and outcomes for women, children and adolescents.

OUR APPROACH

Nutrition International has been working closely with the government of Bomet County since 2017 to help improve the nutritional status of its population. This requires involvement, leadership and coordination of county officials from various sectors including health, education, finance, agriculture, gender and social protection. Planning, implementation, monitoring and reporting of program activities is led by the County Health Management Team (CHMT), which includes the County Health Director, County Nutrition Coordinator, Reproductive Health Coordinator, Health Accountant, County Child Health Services Coordinator, County Health Promotion Officer and County Community Services Coordinator. At the sub-county level, the implementation team consists of departmental heads who work closely with the CHMT, Community Health Extension Workers and Community Health Volunteers (CHVs). Nutrition International's County Program Coordinator oversees program implementation and facilitates the provision of technical support from the national office.
